Hospice Documentation . Hospice providers must establish and maintain a clinical record for every individual receiving care and services. The record must be complete, promptly and accurately documented, readily accessible and systematically organized to facilitate retrieval.

DOCUMENTATION OF APPETITE Appetite usually is a good indicator of decline in a hospice patient. Avoid documentation of good, fair or poor appetite. This cannot be measured. Instead give the number of meals that the patient ate per day along with the % of intake of each meal. Get down to even describing the meal provided in
