On days when there's no school and in the summer, working hours can increase to 8 hours a day and 40 hours per week. There are limits on when 14- and 15-year-olds can work, too. They can only work between 7 a.m. and 7 p.m. during the school year, and between 7 a.m. and 9 p.m. in the summer (between June 1 and Labor Day).
